## **Application Requirements & Process**

Applications will need to include the following supporting documents:

- Robust Business / Growth Plan
- Market validation evidence
- Previous 12 months cashflow (if already trading) AND 12 months forecasted cashflow
- Proof of minimum 50% ownership by applicant and/or other registered whānau
- Proof of GST registration (if relevant)
- Proof of bank account
- Photo ID

Next Steps:

- Send your completed application form and supporting documents to puna.pakihi@ngaitahu.iwi.nz
- · Completed applications will be accepted at anytime.
- Applications received before 20th of each month will be reviewed at the beginning of the following month.
- Applications received after the 20th will be reviewed two months later.
- Please ensure your application is complete to avoid delays in receiving your grant.

NB: Whānau are only eligible for 1 grant payment each financial year, being year ending 30 June. With a 12-month stand-down between successful applications.

## Which grant are you applying for?

Kickstart: New business or within first 12 months of Company registration

Stay-up 1: Company registered over 12 months, revenue under \$60,000 and not GST-registered

Stay-up 2: Over 12 months of trading, revenue between \$60,000 - \$120,000 and GST registered

Growth: Over 12 months of trading, revenue more than \$120,000, GST registered and funding will support a step-change in growth for the business
